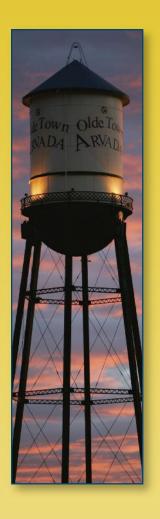

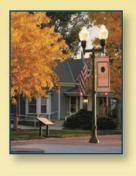

# 2007 Promotions Committee Accomplishments

The Promotions Committee promotes Olde Town through festivals and special events. Our festivals and special events attracted over 25,000 people to Olde Town in 2007. These events, and the visitors they attract, enhance the economic viability of our district and generate a positive public image, which in turn attracts more patrons as well as new businesses.

Our oldest and largest event, the Gold Strike Festival, celebrates the first documented gold strike in the State of Colorado in Ralston Creek in June of 1850. This Festival honors our heritage, such as transforming McIlvoy Park into an Historic Reenactment Park, while showcasing our modern businesses. Over 12,000 people came to Olde Town Arvada for the 2007 Gold Strike Festival, an increase of 67% over 2006. The committee is already hard at work to bring the best ever Gold Strike Festival to Olde Town in 2008.

The Promotions Committee plans and organizes a dozen events throughout the year, ranging from "A Chocolate Affair" to "Flicks in the Square" (outdoor movies in Town Square) to an extensive holiday celebration, including carriage rides and

carolers every Friday in December. In addition, the committee partnered with the Arvada Festivals Commission to produce the 11th Annual Festival of the Scarecrows, and with the Arvada Child Advocacy Center, now known as Ralston House, in producing the 1st Annual .5K Endurance Challenge.

Thanks to a one time grant of from the City of Arvada and partial matching funds from HOTA, local business owners and staff produced a full year of marketing efforts for our district. These efforts included publishing a directory of all Olde Town businesses and quarterly direct mail campaigns that included drawings for prizes ranging from a round-trip for two on Frontier Airlines to a golf and dinner package at Westwoods Golf Course.

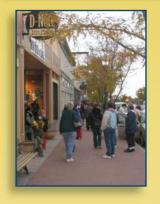

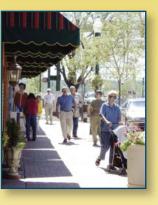

## 2007 Organization Committee Accomplishments



The Organization Committee provides ongoing management of the association and advocacy of Olde Town. The Committee focuses on developing partnerships among the various stakeholders, both within the local community and the broader Denver Metro Region. The involvement of diverse groups, representing the public and private sectors, is a key to maintaining a successful Main Street program. The Committee assures communication within the Olde Town community and with our many partners to assure successful events and ongoing operations.

During 2007, the Organization Committee spearheaded Historic Olde Town Arvada's charter membership in the **Original Shopping Districts Network (OSD)**, a unique partnership of Metro Denver historic shopping venues. The **Original Shopping Districts Network** is the first and only organization in the country created to cross-market throughout multiple historic shopping venues. This partnership expands our marketing reach throughout the region, thus complementing our statewide presence (through the Colorado Community Revitalization Association) and a national presence (through the National Main Street Program).

Partnerships with community organizations are

an important part of HOTA's foundation. By sharing resources, both organizations can achieve far greater results than any solo effort. Six partnering organizations are members of our Board of Directors and work closely with HOTA in our activities. In addition, many other community groups share in our events by providing volunteers or other direct participation. The Organization Committee oversees this involvement with these community organizations and maintains open communications with them.

In November 2006, we launched our first sponsorship campaign in an effort to diversify our funding base. This six-month effort attracted 13 new annual sponsors, whose generosity and commitment provided a meaningful proportion of our funding in 2007.

During 2007, the Organization Committee devoted substantial resources to researching the possibility of incorporating as a 501(c)(3) tax-exempt organization. This potential change from our current 501(c)(6) tax-exempt status would enable us to apply for a wide wide range of grants, the vast majority of which are available only to 501(c)(3) organizations.







# 2007 Economic Restructuring Committee Accomplishments

The Economic Restructuring Committee is focused on business retention, expansion and recruitment. This Committee seeks to assure a balanced business mix within Olde Town and to support the ability of Olde Town businesses to grow and remain competitive.

During 2007, the Economic Restructuring Committee created an educational guide for new business owners. This guide contains essential start-up information needed by a new small business to be successful. In addition, it provides a wealth of information regarding government agencies and other available resources, such as non-profit organizations and educational institutions.

The Committee began the process of developing a business recruitment strategy during 2007. After reviewing the efforts of other historical districts, we are designing a business recruitment and retention program for Olde Town Arvada, to be implemented in 2008. We are looking forward to working with property owners to recruit businesses for vacant spaces, as well as to assist those businesses in achieving success in Olde Town.





In addition, the Economic Restructuring Committee is responsible for our monthly Historic District Business meeting. These monthly meetings are designed to inform and educate our District's businesses. Speakers have included Don Gallegos former president of King Soopers, Tameka Montgomery - Denver Chamber of Commerce, and Denise Stephens - Jefferson County Business Resource Center. These meetings also give our businesses the opportunity to assist in planning major events, such as the annual Gold Strike Festival.

## 2007 Design Committee Accomplishments



The Design Committee focuses on preserving the historical and aesthetic ambiance of Olde Town Arvada. The pedestrian shopping experience of today is enhanced by charming streetscapes that complement well-maintained historic buildings. The Design Committee maintains and stimulates our downtown's economic viability through street and building maintenance. As part of this mission, the Committee also addresses transportation access to Olde Town and parking, as well as reviewing plans for new construction and how it complements the historic district.

During 2007, the Design Committee completed the Olde Town Arvada Maintenance Manual. This manual focuses on the wide range of City codes, such as signage, that impact every business. In addition, the Committee planned and organized our 2nd Annual Downtown Clean-Up Day. Over 15 volunteers scoured the streets and sidewalks to rid them of debris, grease, and gum. Working side-by-side with business owners and Board members, we demonstrated to the community that each of us has an obligation to preserve and protect our historic district.
